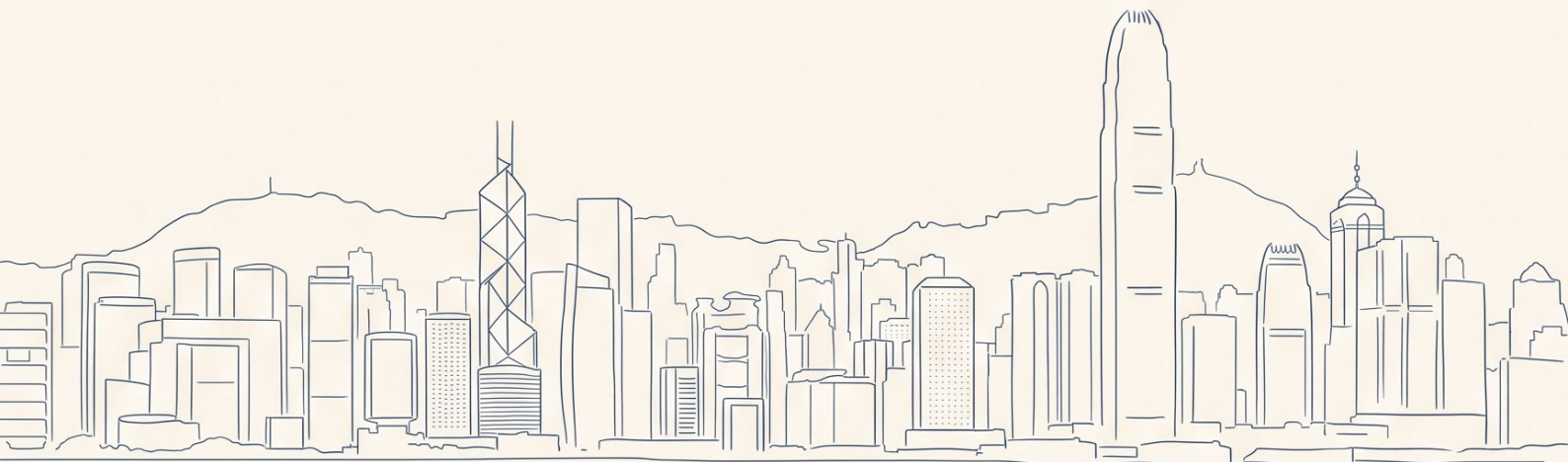
What to prepare

- ✓ Company name (EN / CN optional)
- ✓ Director & shareholder ID + proof of address
- ✓ Shareholding split
- ✓ A one-line description of your business

Statutory requirements

- ✓ One local company secretary
- ✓ One Hong Kong registered address
- ✓ At least 1 director + 1 shareholder (can be the same person)

Company secretary + registered address — we provide both

3**Profits tax filing**

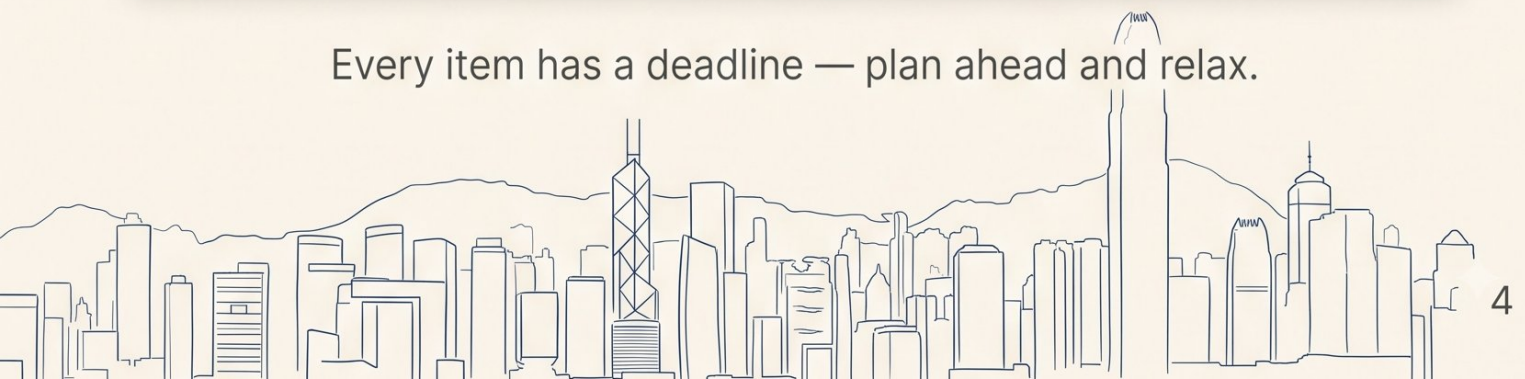
Two-tiered rates: 8.25% / 16.5%
